'ChatGPT Can't Beat Humans in Accounting'



NEW DELHI: AI chatbot ChatGPT is still no match for humans when it comes to accounting. The AI still has work to do in realm of accounting, say researchers. OpenAI's newest AI chatbot GPT-4 passed the bar exam with a score in

90th percentile, passed 13 of 15 advanced placement exams and got a nearly perfect score on the GRE Verbal test. Researchers at BYU and 186 other universities wanted to know how OpenAl's tech would fare on accounting exams. Although ChatGPT's performance was impressive, the students performed better. Students scored an overall average of 76.7%, compared to ChatGPT's score of 47.4%. The AI bot did worse on tax, financial, and managerial assessments, said the study published in the journal Issues in Accounting Ed-Ucation. - Agencies

USERS - CAPABILITY



And...

It boils down to how you PROMPT. **SLICE** the prompt.



1. Specific

Meaning: Clearly state what you're looking for in your prompt.

Poor prompt: "Tell me about revenue recognition in accounting."

Good prompt: Please explain the IFRS 15 revenue recognition standard and its specific implications for revenue recognition in the telecommunications sector."

2. List Role



Meaning: Give it a role. Tell it to act like a doctor, like a financial analyst etc.

Poor prompt: Discuss tax planning strategies for a medium-sized technology company.

Good prompt with List Role: As a tax expert explain how you would devise tax planning strategies for a medium-sized technology company aiming to minimize tax liabilities while ensuring compliance with the latest tax laws and regulations.



3. Instruct

Meaning: Give enough background information to help the model understand the context of your prompt. Context helps

Poor prompt: Talk about the importance of audits in business.

Good prompt with Instructions: Act as an experienced CA, provide a detailed explanation of the role and significance of internal and external audits in ensuring financial transparency and integrity within a <NAME TYPE OF INDUSTRY>. Include specific examples of how effective audits can contribute to risk mitigation. Highlight key considerations and best practices in the audit process.



4. Constraints

You can add constraints to guide the response, such as "Write a story in 100 words" or "List three reasons why."

Poor prompt: "Explain the process of budgeting and forecasting in business."

Good prompt with a constraint: As a financial expert, describe the budgeting and forecasting methods commonly used in the technology sector. Provide insights into how these methods can be optimized to address challenges related to cost control and efficiency, considering the constraints of a start-up with limited initial capital. Write in 100 words.

Meaning: Provide it with an example for it to understand what you see. Ask it to give examples so that you can understand better

Poor prompt: Discuss risk management in financial contexts.

HOW TO WRITE PROMPTS

5. Examples

Good prompt seeking examples: As a CA, elaborate on the strategies and methodologies involved in effective financial risk management. Give examples to illustrate how companies have successfully identified, assessed, and mitigated financial risks, particularly in volatile market conditions.
