

The Story behind the word "Return" in ITR

When we talk about filing our ITRs, most of us don't pause to think — why exactly is it called a "return"? The answer takes us on a fascinating journey through British legal tradition, colonial India, and the evolution of our tax laws.

Origins in Language

The word return comes from the Old French retorner and Latin re- (back) + tornare (to turn). In English legal usage, dating back to the 15th century, a "return" meant a formal report submitted back to an authority whether it was a court, government, or other official body. This concept travelled with British administrators across their empire, including India, and found a permanent place in our taxation vocabulary.

Early Use in Indian Tax Law

1860 - The First Income Tax Act in India

Introduced by Sir James Wilson after the Revolt of 1857 to raise revenue. Required taxpayers to "furnish a return of income" — the first time "return" appears in Indian tax legislation.

1886 & 1918 Acts

Continued the practice, using "return" to describe the statement of total income that taxpayers were obliged to submit. By 1918, penalties for failure to submit a return were codified.

Modern Legal Framework

1922 Act

Established the structured system of original, revised, and defective returns. Cemented "return" as a statutory term.

1961 Act (Current)

Sections 139-142 deal specifically with "Furnishing of returns of income." Even with e-filing, the law still speaks of "furnishing a return of income" — a nod to our legal heritage.

Global Continuity

India isn't alone. The UK's HMRC and the US IRS also use "tax return," preserving this centuries-old terminology across jurisdictions that share common law roots.

Why Not Call It Just a 'Form'?

Because in law, "return" is more than a form — it is a mandatory, official submission made in response to a statutory requirement. The word carries the weight of obligation, legal consequence, and accountability.

A Quick Timeline

Year	Event
1860	First Indian Income Tax Act – "return of income" appears
1886	Standardisation of "return of total income"
1918	Penalties for non-filing introduced
1922	Original, revised, defective returns defined
1961	Current Income Tax Act – "return" remains core term

2000s e-Filing introduced, terminology unchanged

In short: When you "file a return," you're not getting something back — you're returning information to the government, just as taxpayers did more than 160 years ago.




