THE IMPRESSION THAT LINGERS...

(A TRIBUTE TO LATE SUKUMARA MENON)

My association with Sukumara Menon or Menon Sir, as he is fondly called, was not long or for that matter very frequent, but the short moments we were together has left lasting impressions in my mind, which stays at the bottom of my heart as crowning jewels.

I left Thrissur after pre-degree (today's +2) and returned after 15 odd years to set up shop as a professional. I was totally out of touch with the happenings around here. What I had was the fire in the belly and the confidence I had acquired by working for almost 7 years in a transnational Company like Hindustan Levers. That was the time I needed a father figure in the profession to guide me in steering my professional path.

One of the first CA professionals I met in Thrissur was Menon Sir. Though our first meeting was very short and crisp, I could feel a thread of commonality running through us when he briefly explained about his humble beginning as a professional. I noticed the glee in his eyes and the self satisfaction he derived narrating his success story. He was 56 years then, on a strong wicket completing 30 years in practice.

The next time we had such personal moments been after a year and one half, when I called on him at his office, with an invitation for my marriage. When I told him that I am getting married to a doctor, he with his characteristic laugh jocularly remarked "don't expect her to be at the door steps with a cup of tea when you return home after a day's hard work" (my wife is striving hard to ensure that his prophecy comes true!! ha ha).

The corridors of the Income Tax Office were the meeting ground (Kurushetra), when we both waited for our turns to be called in by the Officers for hearings, where his avuncular exhortations on leading a happy life, on being a good professional, on balancing personal and professional life etc, transpired. Menon Sir was a thoroughbred professional and even in his eighties he attended all lectures and conferences with the spirit and alacrity of a 1st standard student, sitting in the front row, at times nodding his approval of what the speakers, much younger to him, said.

He was a multifaceted personality and he believed in a life beyond the profession. It is often said that a leisure a person chooses, subtly reflects his personality. His interest outside the realms of his professional life constituted a kaleidoscope which created the fascinating and beautiful patterns of the expanse of his mind, distinguished as much by the felicity of his exuberance.

The aching void of his unexpected physical departure from this planet of ours, shall linger like a lissom teardrop, marooned in an island of private sorrows, for years to come. I personally feel that he would have had still many more horizons to cross over, many frontiers to explore and many trees to nurture, but for his demise.

Menon Sir lived a life of contentment till his end at 89 years. During our hours of solitude, it is but natural that we miss a person who has influenced us. But, then we have to be a bit philosophical and try and think of the story about a little wave, bobbing along in the ocean, having a great time, enjoying the wind and the fresh air-until he notices the other waves in front of him, crashing against the shore. "My God! This is terrible", the wave says. "Look what's going to happen to me!"? Then along comes another wave and seeing the first wave, looking grim, says "Why look so sad?" The first wave says, "Don't know? We're all going to crash! All of us waves are going to be nothing! Isn't it terrible?" The second consoles: 'No, you don't understand. You are not a wave; you are part of the Ocean.'

20th May 2021 will continue to be a black day for us as long as we live. Shri V Sukumara Menon our Guru, our mentor and the person responsible for making us what we are today left the world on that day.

Our bonding with Menon Sir started in October 1984 when we commenced articleship under him. His hard work and discipline made him a role model for all his students. As his articled assistants we observed his capacity to work ceaselessly and enthusiastically on a regular basis which impressed us a lot.

Shri V Sukumara Menon was born on 22nd June 1931 into a middle class family in Peringottukara, Thrissur. His father was Raman Nambiar a Government employee (who passed away when Menon sir was still a child) and mother Kochukutty Amma, a homemaker. Brought up under the guardianship of his elder brother, who was a doctor, Sukumara Menon sir was fired up with the ambition to become a doctor in his younger days. He completed his graduation in Science with this aim in view. However fate had something else in store for him. He was inspired by his sister's husband, who was a practicing Chartered Accountant in Chennai, to pursue the CA course in Chennai.

After passing his CA Final Exams he returned to Thrissur and set up practice in the year 1958 in a one roomed office in Round West Thrissur. He continued his practice there for the next 30 years or so as a sole practitioner. He also took up part time employment as a teacher in the Commerce Department of Sree Kerala Varma College Thrissur from 1958 to 1963. He was the senior partner in the firm M/s Sukumara Menon Jose Paul & Ramdas from 1986 to 2004 and in the firm M/s Sukumara Menon Venugopalan & Sathi from 2004 to 2019. He was the founder chairman of Trichur Branch of SIRC of ICAI.

He achieved the milestone of completion of 50 years of Professional Practice on 01.05.2008 and was felicitated at a meeting attended by a galaxy of eminent CA's. He retired from active practice after a marathon of 60 glorious years in practice. After his retirement from our firm M/s Sukumara Menon Venugopalan & Sathi he graciously consented to our request to allow us to continue to use the same firm name. His career was blemish less and a model worthy of emulation.

For him, the CA profession was not just a means to earn his daily bread and butter, it was a lifelong passion. This passion was evident from the fact that even in his eighties he continued to attend all the seminars, unfailingly sat in the front row and was the first to raise questions after the paper presentations were completed. He was honest and frank in voicing his opinions and did not hesitate to call a spade a spade. Fear of the higher authorities in the Government departments did not curb his tongue and he was the first to raise his voice when it appeared as if an injustice was being done to the CA community or the taxpayers. As the future of the CA Profession was a matter very close to his heart, he continued to do this even in the later years of his life.

On a lighter note, he was very fond of his cars and continued to drive his car right up to a few months before his death with the same confidence and zeal which he had exhibited in his younger days. In spite of repeated entreaties from his close relatives he refused to employ a driver for his car.

Condensing our experiences with him over the past 37 years into a few pages is a herculean task and does not do justice to the towering personality that he was. We consider ourselves twice blessed to have known him and learnt from him firstly as our principal during articleship and later on as a partner in our professional practice.

He lived his life on his own terms and had a very positive approach to life. The passion and dedication he brought to his work was what made him a legend in Thrissur. Menon sir used to talk with great fondness of many of his former students who now occupy high positions in Government, business and professional practice. His legacy will live on.

- S Stylish- Menon Sir always appears professionally dressed.
- **U Unique** Menon Sir has got his own style of addressing everyone. For him everyone was "Moopar". Even if he forgets someone's name, it will not be evident.
- **K Knowledge Savvy-** Even at advanced age, he used to actively participate in all the seminars and raised meaningful and relevant queries.
- U Unmindful—Menon Sir was simple, straight and unmindful of the ways of the world and never bothered to care about what others thought. Whoever meets him after some time, must have to reply to his question, "Moopare, Ippo ningale pole ulla orallku avide ethra Kittum?"
- M Majestic- Whenever he enters a place, he captures the attention of everyone with the way he walks, straight and head high.
- **A Athletic-** Menon Sir always cared for his fitness. Even though half his age, I used to struggle to keep pace with him when we walked together.
- **R Relaxed-** After office hours Menon Sir liked to live his life to the fullest. His presence was there in all the cultural events and he loved to be amongst the crowd.
- **A Accountant-** He was an accountant to the core. During our Articleship period, we used to go to Menon Sir's Cabin to sign for the receipt of stipend. He was a perfectionist in accounting and used to ask details for each and every small expense incurred.
- M Memory- Menon Sir had a very sharp memory; once a person gets introduced to him, even after many years he remembers and recollects all the relations in a flash of a second.
- **E Gender Equality** Our articleship period was in a time when most of the Chartered Accountants were reluctant to take girls as articled students. But majority of articles in SJR were girls; moreover, Menon Sir had a Lady Professional Partner Sathi Madam.
- N-No Compromise- Menon Sir never compromised on Discipline. When he was in office, there will be pin drop silence. Even though I have never seen him shouting or in an angry mood, all of us were very afraid to get into his cabin.
- **O On Time Every Time-** One thing Menon Sir instilled in all his students is punctuality. He was on time every time and he expected others too to be punctual. Even at his advanced age, he used to reach the meeting place before time.
- **N No Nonsense-** Menon Sir was not a person who sits around and make small talks. If you went to him to discuss about something, immediately on finishing that topic, he will ask "Shari Moopare, Vere Onnum Illallo?". His way of saying… that he has better things to do.

Thank you, Menon Sir, thank you for everything.

It was great knowing you and being one among the many proud students of yours, around the world. You will always be there in our hearts and we all pray to the Almighty that you Rest in Peace...

CA V Sukumaramenon, widely accepted and called as Menon Sir was a legend in the profession of CA in Thrissur. I did my articleship under him in erstwhile Sukumaramenon Josepaul and Ramdas(commonly known as SJR at that period) When I joined for my CA, he was about to leave his active practice, by handing over the responsibilities to Josepaul Sir and Ramdas Sir. But the sudden accidental death of Josepaul Sir forced him to be more active in practice a little more period. In the very first day itself I was a little afraid of going to his Cabin. He never fired me. But his charismatic face always prevented the articles to go to his cabin freely.

He is a person using a lot of Malayalam words in his professional practice. Some of the words may not be familiar for the new generation Chartered Accountants. Many of his Malayalam words and phrases, we used to enjoy by changing the words and its meaning. (Of course without his knowledge). Some of his Malayalam words while in practice

Neekkiyirippu (We changed to Kayyilirippu)- Cash Balance

Sumaar (We changed to Kumar) Around

Mooppare You Bhesh Good

Naalvazhi (We changed to Edavazhi) - Day Book

Peredu Ledger

And so on....

Once one of his client died and the matter was informed to him over the phone by his relative. Menon sir was saying.... Nannayi Moopare....By hearing from his cabin, we all laughed. What he meant by saying Nannayi Moopare is appreciating the caller for the right information in right time. But we interpreted in another way.

The three exceptional qualities I noticed in my association with him are

- 1. Hardcore commitment to the profession.
- 2. Punctuality and Timeliness
- 3. Financial Discipline.

He never compromised to the qualities of the work. Many a times I noticed he teaches the client and their Accountant continuously for improving the accounting procedures and tax compliances. The patience he has shown to the clients and their Accountants requires a special mention here.

He was so disciplined to come at office by 9.30 am, leaves at 1 pm and again comes at 3.15 pm and leaves at 5.45 pm even after handed over his responsibilities to the next generation.

We can adjust our watch by looking at his arrival and departure in/from office. An admirable quality, still I follow in my office also.

He was so particular in financial matters including our expense reimbursement. Since he was the custodian of cash (at that time), he will settle our claim exactly to the paisa. Four years back when I invited him for the inauguration of my office building, he asked me in detail the financial aspects of the building and cautioned me about the capital expenditure and the Cash Inflow outflow in the practice. Menon sir was always straightforward and never hesitant to ask anything to anybody. He came for the office inauguration at the age of 86 by driving his Car. Once when I came for a vacation from Dubai, I visited him and during the talk he without any hesitation asked me about my Salary and other perquisites. His straightforwardness we have seen in our Branch in many of his talks.

I recollect my memories as a student, not as a CA. Even though he never tested my knowledge, qualities or discipline during my articleship, I was always feeling a fear of respect to Menon Sir. I never sat in front of him during my articleship period. His charismatic face and feel of respect always prevented me (or most of the students) to freely interact with him during the articleship period. But an inner desire to follow his certain qualities throwing light and guiding principles in my professional career.

Death is inevitable. Menon Sir has lived to his satisfaction. He contributed to the profession and the society in large. I bow my head as a student and may his soul Rest in Peace.

I joyfully recollect the good old days I had spent at the office of Sri. Sukumara Menon Sir, while pursuing my CA Articleship Training from 1996 to 1999.

I joined Menon Sir's office in the year 1996, two years after my Post Graduation. At that time, Senior Chartered Accountants, Sri. Ramdas Sir, Venugopalan Sir and Sathi Madam were also practicing there. They handled all most all matters connected with the training of students and Audit works. Hence we, students, had minimum occasions to interact with Menon sir. But we all were aware that Menon sir was constantly monitoring the performance and progress of each and every student.

I remember my first meeting with Menon Sir. I think, it was on the day I joined Menon Sir's office for my Articleship Training. 
I got chance to do my articleship in firm where Sukumara Menon Sir was a Partner. Those days of articleships introduced me to the world of an office first time in my life.
