



Delegate and empower:

Many practitioners shoulder every responsibility. Training juniors or outsourcing repetitive tasks can free bandwidth for strategic thinking — and personal well-being.

The next era belongs to those who:

- Keep learning even when busy,
- Embrace AI instead of resisting it,
- Prioritize mental health alongside compliance,
